INTERIM ORDER ON EXPEDITED MOTION FOR AUTHORITY TO USE CASH COLLATERAL

Upon the Debtor's Expedited Motion for Use of Cash Collateral [Docket #2], the Objection of Amazon Fulfillment Services, Inc. - 4. Upon Amazon's request, the Debtor shall make it management personnel available, within reasonable notice, to answer questions raised by Amazon about the ongoing day to day operations of the business.
- 5. The Debtor shall continue to provide upon request an accounting of all inventory currently in Tadd's possession as of the date of this Order.
- 6. Upon Amazon's request, the Debtor shall produce true and correct copies of any other documents related to the administration of Tadd's business related to the Amazon inventory to Amazon within seven (7) days of Amazon's request.
- 7. Debtor shall file an Application to Employ, pursuant to Rule 2014(a) of the Federal Rules of Bankruptcy Procedure and Section 327(a) of the Bankruptcy Code, Gary M. Murphey and Resurgence Financial Services, LLC as Chief Restructuring Officer.

8. This motion shall be reset for January 9, 2018 at 9:00 a.m. in Courtroom Three of the Customs House, 701 Broadway, Nashville, Tennessee, 37203.
