**RESOLUTION
MART APARTMENTS, LTD.**

FEBRUARY 1, 2008

The undersigned, being the General Partners of Mart Apartments, Ltd., a Texas limited partnership (the "Partnership") do hereby unanimously adopt the resolutions and the authorization of the corporate actions hereinafter set forth.

WHEREAS, the Partnership is indebted to the United States Department of Agriculture, Rural Development ("USDA"); and

WHEREAS, the Partnership is alleged to have committed certain defaults related to that indebtedness and, due to financial difficulties created by continued delay of the USDA, cannot presently cure the default; and

WHEREAS, the indebtedness owed to USDA is secured by all real property owned by the Partnership; and

WHEREAS, USDA has posted all real property owned by the Partnership for foreclosure with such foreclosure scheduled to occur on February 5, 2008; and

WHEREAS, the General Partners have determined that it is in the best interest of the Partnership to file a voluntary petition for relief under chapter 11 of the Bankruptcy Code; and

WHEREAS, the General Partners have determined that it is in the best interest of the Partnership to retain the law firm of Forshey & Prostok, L.L.P. and any and all other professionals that may be necessary to or beneficial in assisting the Partnership in filing and proceeding in bankruptcy;

NOW THEREFORE, BE IT

RESOLVED, that the Partnership shall be, and it hereby is, authorized, directed and empowered to file a voluntary petition for reorganization pursuant to the provisions of chapter 11 of the Bankruptcy Code, 11 U.S.C. §§ 101-1532 (the "Bankruptcy Code"), and to perform any and all such acts as are reasonable, advisable, expedient, convenient, proper or necessary to effect any of the foregoing;

FURTHER RESOLVED, that the General Partners, or the officers and directors of any General Partner (collectively, the "Officers and Directors") shall be, and each of them hereby is, authorized, empowered and directed to execute, on behalf of the Partnership, the voluntary petition of the Partnership, and any and all other documents necessary or appropriate in connection therewith in such form or forms as he, she or they may approve;

FURTHER RESOLVED, that Jeff P. Prostok and the other affiliates of the law firm of FORSHEY & PROSTOK, L.L.P., shall be, and hereby are authorized, empowered and directed to represent the Partnership, as debtor and debtor in possession, in connection with any case commenced by or against it under the Bankruptcy Code;

FURTHER RESOLVED, that the Officers and Directors shall be, and each of them hereby is, authorized, directed and empowered to retain on behalf of the Partnership such other attorneys, financial advisors, and accountants as the Officer(s) or Directors(s) so acting shall deem appropriate in his, her or their judgment;

FURTHER RESOLVED, that the General Partners of the Partnership or an Officer or Director of such General Partner shall be, and each of them hereby is, authorized and directed to take or cause to be taken any and all such further action, to execute and deliver any and all such further instruments and documents and to pay all such fees and expenses, as the General Partner, Officer(s) or Director(s) so acting shall deem appropriate in his, her or their judgment to fully carry out the intent and accomplish the purposes of the Resolutions; and

FURTHER RESOLVED, that all of the acts and transactions of any one or more of the General Partners, or their Officers or Directors, which have been taken or made prior to the effective date of the Resolution, shall be, and they hereby are, ratified and approved.
