Whereas the litigation has caused both significant increases in Casa Blanca insurance rates and exclusions in Director's and Officer's coverage related to said litigation, and

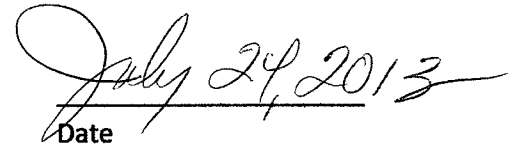
Whereas the Association management company resigned due to the Association insolvency, and

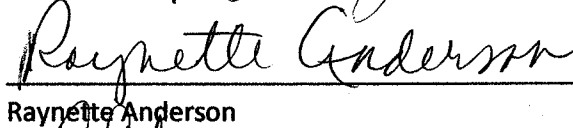
Whereas the financial condition of the Association does not provide sufficient funds for repairs and deferred maintenance on the property,

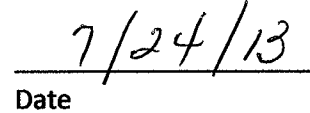
Therefore, be it resolved that the Board of Directors hereby agrees to seek protection for the Association under Chapter 11 bankruptcy.
