#### STATEMENT OF OPERATIONS

The current owners bought the hotel in 2014 when it was grossing about \$450,000.00 per year.

After 1 year, under current management, gross revenues rose to \$1,359,985.00 in 2014. This increased to \$1,918,477.00 in 2015. And they increased again in 2016 to \$2,300,735.94.

Since then, there have been challenges by the local regulatory agencies to make 450 minor repairs to plumbing, the fire alarm, water sprinkling system and doors. The hotel was shut down for these repairs in June and July of 2016, and in December 2016. This hurt revenues and caused the hotel to fall behind on its bills. Projected revenues without shut downs for repairs were \$3,360,000.00.

These necessary repairs, which cost over \$800,000.00, are now nearly complete. The hotel expects to reopen soon and continue its increasing gross revenues going forward.

It anticipates filing a Plan of Reorganization to repay about 77% of its debt over 60 months.
