
CERTIFICATE OF RESOLUTION

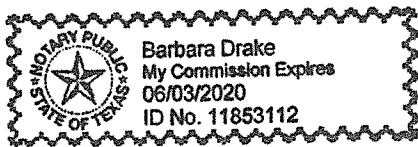
