ORDER ON MOTION FOR INTERIM USE OF CASH COLLATERAL

CAME on this day to be considered the Emergency Motion to Use Cash Collateral filed by Dallas Barbecue, LLC, Garland Barbecue #1, LLC and Farmers Branch Barbecue, LLC on October 30, 2018, and it appearing from the representations of the Debtor set out in the said Motion, and the evidence heard, that an emergency need exists to order the relief herein on an interim basis and that it is in the best of the Debtors, the Debtors' estate and Debtors' creditors, to authorize the Debtors to use cash collateral is the only means available to Debtors to finance their operations at the present time. The Court finds that immediate and irreparable harm will result if the Debtors are not permitted to use the cash collateral in the amounts set forth in the Budgets. It is accordingly,

ORDERED that the Debtor be and is by this Order authorized to use on an interim basis the cash collateral and proceeds in which Liftforward, Inc., Sysco Corporation, BBCN Bank, Supersonic Funding, and Dickeys Capital Group ("collectively "secured Creditors") assert lien positions in accordance with the provisions in the Budget attached hereto as Exhibits A, B, and C. It is further

ORDERED that as adequate protection the Secured Creditors are hereby granted replacement liens co-existent with their pre-petition liens, under 11 U.S.C. §552 in after acquired property of the estate. It is further

ORDERED that a hearing will be held on November 19, 2018, at 1:30 p..m. o'clock in the Courtroom of the Honorable Harlin D. Hale, United States Bankruptcy Judge, 1100 Commerce Street, 14th Floor, Dallas, Texas, to determine if this Order should be continued, modified or terminated.
