



**WRITTEN CONSENT OF THE SOLE MEMBER



RESOLVED FURTHER, that any and all actions taken by the Agent, for and on behalf and in the name of this Company, prior to the adoption of the foregoing resolutions, in connection with any of the foregoing matters, be and they are hereby, ratified, confirmed and approved in all respects for all purposes.

The undersigned, being the sole Member of the Company hereby consents to the foregoing effective the 25th day of July, 2017.


