FINAL ORDER ON EMERGENCY MOTION PURSUANT TO 11 U.S.C. § 363 FOR AUTHORITY TO USE, SELL, OR LEASE CASH COLLATERAL IN THE ORDINARY COURSE, PROVIDE ADEQUATE PROTECTION AND FOR PRELIMINARY HEARING

On March 5, 2017, came on for consideration the Debtor's Emergency Motion, pursuant

to 11 U.S.C. § 363, for Authority to Use, Sell, or Lease Cash Collateral in the Ordinary Course,

Provide Adequate Protection and for Preliminary Hearing (the "Motion"). After considering the

Motion, the evidence presented, and the statements and argument of counsel, the Court finds that

the use, sale or lease of cash collateral is in the best interests of Debtor and its bankruptcy estate

and should be approved.

It is therefore, **ORDERED**, **ADJUDGED** and **DECREED** that the Debtor is hereby temporarily authorized to use cash collateral to pay its usual and necessary operating expenses as set forth on the attached budget.

It is further, **ORDERED**, **ADJUDGED** and **DECREED** that the Debtor may exceed any line item on the budget by 25% so long as it does not exceed the total allowance for cash collateral for the month by more than 10%.

It is further, **ORDERED**, **ADJUDGED** and **DECREED** that all parties with an interest in cash collateral are granted a replacement lien to the same extent, priority and validity as their pre-petition liens.

It is further, **ORDERED**, **ADJUDGED** and **DECREED** that the Debtor shall provide adequate protection to the creditor Bank of America, N.A. ("BOA") as follows:

 The Debtor shall continue to maintain insurance protecting the interest of BOA in its collateral from loss as required by the underlying loan documents executed in favor of BOA;

(2). The Debtor shall continue to remit regular monthly payments to BOA.

It is further, **ORDERED**, **ADJUDGED** and **DECREED** that this order shall be without prejudice to any secured creditor filing a separate motion for adequate protection or a motion for relief from the automatic stay.
