**EMERGENCY MOTION FOR INTERIM AUTHORIZATION**  
**TO USE CASH COLLATERAL**

TO THE HONORABLE H. CHRISTOPHER MOTT, UNITED STATES BANKRUPTCY JUDGE:

Now comes RUBEN JASSO TRUCKING, LLC, Debtor-in-Possession in the above captioned Chapter 11 proceeding, and through its attorney undersigned files this Emergency Motion for Interim Authorization to Use Cash Collateral, and would respectfully show as follows:

1.

Petition date in these Chapter 11 proceedings is September 28, 2018.

2.

RUBEN JASSO TRUCKING, LLC is a Missouri Corporation which has all of its assets in El Paso, Texas, where it has operated for 12 years. In the regular course of its business, RUBEN JASSO TRUCKING, LLC is a heavy commercial vehicle ownership company. The only form of cash collateral is an account receivable which the Debtor receives from an affiliate, NT3, LLC, which operates, insures, and maintains the vehicles, and pays the Debtor rental for their use. As of petition date the collectible receivables stood at \$126,666.66. That is one-third of the total truck rental (\$380,000.00) owed to the Debtor by its affiliate. This account constitutes "cash collateral" within the meaning of 11 U.S.C. § 363(a).

3.

Debtor's counsel conducted the UCC search which is hereto attached, as Exhibit "A," along with the UCC-1 filings. The first priority lien on receivables is held by COMMERCIAL

CREDIT GROUP, INC. ("CCG"). There is one other entity, MARQUETTE TRANSPORTATION FINANCE, LLC, which has filed a competing (but later) UCC-1 against the Debtor's receivables. MARQUETTE TRANSPORTATION FINANCE, LLC is not owed anything by the Debtor. MARQUETTE TRANSPORTATION FINANCE, LLC purchases freight-hauling invoices from 3NT, LLC and appears to have filed its UCC-1 against RUBEN JASSO TRUCKING, LLC out of apprehension that the two LLC's might fail to observe corporate formality and accidentally become one enterprise someday.

4.

There are no federal tax liens filed of record against the Debtor.

5.

CCG has other, non-cash collateral. CCG is secured by liens appearing on the title certificates for 47 over-the-road trailers having an aggregate value of \$597,000.00, and four 2018 Freightliners having an aggregate value of \$440,000.00. The loan on the trailers has a balance of \$675,000.00. The loan on the tractors has a balance of approximately \$539,800.00.

6.

As adequate protection for the use of CCG's cash collateral, Debtor proposes to continue to make monthly payments of \$39,037.00 each to CCG starting on the 15th of October, 2018; to have a replacement lien in the amount of \$126,666.66 granted to CCG; to keep the accounts receivable at a minimum value of \$126,666.66 post-petition, and to operate only in the ordinary course of business and according to the proposed budget hereto attached as Exhibit "B."

7.

As additional adequate protection for the use of CCG's cash collateral, RUBEN JASSO TRUCKING, LLC is willing to do the following:

- a) Furnish to CCG access to its Monthly Operating Reports in this case;
- b) Implement any further reasonable measures imposed by the Court.

8.

CCG will be adequately protected if RUBEN JASSO TRUCKING, LLC is authorized to use cash collateral, for these reasons:

- a) Use of RUBEN JASSO TRUCKING, LLC's vehicles creates valuable accounts receivable in the regular course of business.
- b) 3NT, LLC has steady contracts and can afford to pay vehicle rental of \$127,600.62 per month to the Debtor;
- c) RUBEN JASSO TRUCKING, LLC is capable of restructuring its debts and reorganizing.
- d) \$39,037.00 is the aggregate total of all monthly installment payments the Debtor ordinarily makes to CCG.

9.

If RUBEN JASSO TRUCKING, LLC cannot collect and use the vehicle rents paid by 3NT, RUBEN JASSO TRUCKING, LLC will be unable to continue in business. It will be unable to service its vehicle financing, and will have to liquidate. In a liquidation, all of its assets will sharply decline in value.

10.


It is in the best interests of this estate that RUBEN JASSO TRUCKING, LLC be permitted to use cash collateral, so that the assets of the estate can bring the best return for all creditors.

RUBEN JASSO TRUCKING, LLC has sought and obtained the consent of General Counsel for CCG to the above measures.

WHEREFORE, PREMISES CONSIDERED, RUBEN JASSO TRUCKING, LLC prays for an interim order containing the terms above and authorizing the use of cash collateral according to the terms set forth above, or such other terms as the Court finds appropriate under the circumstances, to continue until the Court sets a final hearing on cash collateral use. Further RUBEN JASSO TRUCKING, LLC prays for all other and further relief deserved in the circumstances, general or special, at law or equity.

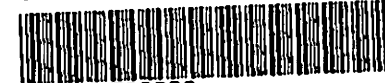
