The Law Offices of Ray Battaglia, PLLC (the "Firm") has been engaged to assist the Debtor in connection with a preparing for, filing and prosecuting a voluntary petition under Chapter 11 of Title 11 of the U.S. Code for Stone Oak Memory Care, LLC ("Stone Oak") in order to protect its assets and reorganize its liabilities. The Firm has agreed to act as Stone Oak's counsel and give advice in connection with the contemplated Chapter 11 proceeding. The Firm will render such ordinary and necessary legal services as may be required in the course of the Chapter 11 cases, including:

- d. Reviewing the nature and validity of liens asserted against Stone Oak and advising Stone Oak concerning the enforceability of such liens;
- e. Advising Stone Oak concerning the actions to be taken to collect and recover property for the benefit of its estate;
- f. Preparing all necessary and appropriate applications, motions, pleadings, orders, notices, schedules and other documents, and reviewing all financial and other reports to be filed in Stone Oak Chapter 11 case;
- g. Advising Stone Oak concerning, and preparing responses to, applications, motions, pleadings, notices and other papers which may be filed in Stone Oak's Chapter 11 case;
- h. Counseling Stone Oak in connection with the formulation, negotiation and promulgation of plans of reorganization and related documents; and
- i. Performing all other legal services which may be necessary or appropriate in the administration of Stone Oak's Chapter 11 case.

The Debtor has agreed to pay the firm an hourly rate of \$475.00 per hour, as adjusted from time to time, in addition to reimbursement of expenses. The Debtor has paid the Firm a pre-petition retainer of \$50,000 plus \$1,717.00 for the Court filing fees in connection with each of the chapter 11 cases. As of the Petition Date, the Firm had applied \$12,466.12 (including the bankruptcy court filing fee) from the retainer to pay prepetition fees and expenses owed to the Firm, leaving a balance in the retainer account of \$39,250.88.
