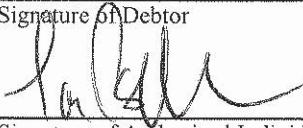

General Notes to February 2010 Monthly Operating Report

Basis of Presentation

Uno Restaurants Holdings Corporation and its subsidiaries (collectively, the “Debtors”) filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code in the Bankruptcy Court for the Southern District of New York (“Bankruptcy Court”) on January 20, 2010.

The accompanying Monthly Operating Report (“MOR”) includes the activity for the Debtors for the period from February 1, 2010 through February 28, 2010. This reporting period has been utilized due to business-defined operational and financial controls along with reporting functions structured around the Debtors’ Monday through Sunday business week, such that sales, receivables, purchasing, inventory, payroll, payables, accruals, and estimates are properly captured and reported with appropriate cut-off procedures to ensure financial accuracy.

The MOR was prepared on a consolidated basis. The information contained in the MOR is unaudited and was derived from the books and records of the Debtors.

The Debtors have recorded adjustments to financial information reported in the previously filed MOR for the period from January 18, 2010 to January 31, 2010. Those adjustments have been integrated into the financial information presented herein. Such adjustments had no effect on revenue, expenses, net income, total assets liabilities, or equity. Furthermore, the financial information contained herein is presented on a preliminary basis and remains subject to future adjustment.

Schedule of Cash Receipts and Disbursements

The Schedule of Cash Receipts and Disbursements reflects the combined activity of all bank accounts for all Debtors on a consolidated basis and has been prepared on a bank clearing basis. Ending cash balance agrees to bank balance on bank-to-book reconciliation. Due to its voluminous nature, the cash disbursements journal is provided in summary format by Debtor only.

Fee schedule is attached and calculated through February 28, 2010 only.

Balance Sheet

- (1) Restricted Cash is held for professional fee carve-out in a separate escrow account at Wells Fargo Bank.
- (2) Amounts due to Insiders are reported on an accrual basis and are for Salary only.
- (3) Priority debt includes prepetition payroll tax withholdings.
- (4) The unsecured debt is for prepetition trade liability.

Status of Postpetition Taxes

Due to its voluminous nature, photocopies of IRS Form 6133 or tax payment receipts to verify tax payments receipts are not attached.

Summary of Unpaid Post-Petition Debts

The Debtors will make payments of postpetition debts in the “ordinary course of business”.

Attached is a listing of unpaid postpetition aged accounts payable.

Accounts Receivable Reconciliation and Aging

The Accounts Receivable balances provided include all Notes Receivable owed.

Payments to Insiders

Payments to insiders have been summarized in order to protect the confidential nature of the information.

Payments to Professionals

There were no payments in February to professionals other than ordinary course professionals entitled to payment pursuant to Bankruptcy Court order.

Postpetition Status of Secured Notes, Lease Payable, and Adequate Protection Payments

These include adequate protection payments for Utility deposits and postpetition payments under our lease obligations.

Debtor Questionnaire

For the payment of prepetition liabilities and taxes, the Debtors obtained certain orders of the Bankruptcy Court shortly after the commencement of the chapter 11 cases designed to minimize the disruption of business operations. These orders authorized the Debtors to pay certain prepetition amounts to, among others, employees, customers, vendors, and taxing authorities. During the period reported in the MOR, the Debtors paid certain prepetition obligations under such orders.

The Debtors incurred postpetition debt under a Final Order Pursuant to 11 U.S.C. §§ 105, 361, 362, 363, 364 and 507 (1) Approving Postpetition Financing, (2) Authorizing Use of Cash Collateral, (3) Granting Liens and Providing Superpriority Administrative Expense Status, (4) Granting Adequate Protection, and (5) Modifying Automatic Stay.

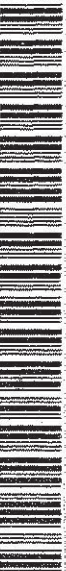
