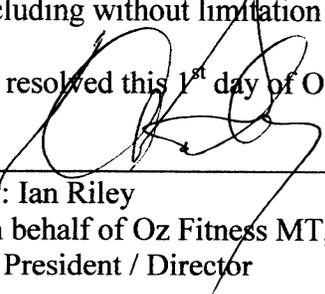
RESOLVED that Oz MT initiate a case under the Bankruptcy Code; and it is further

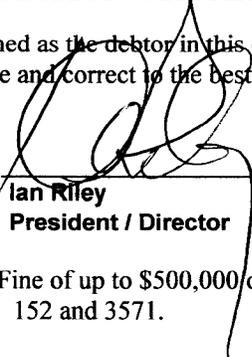

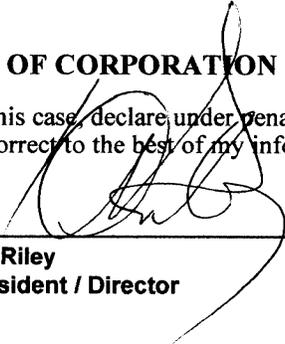

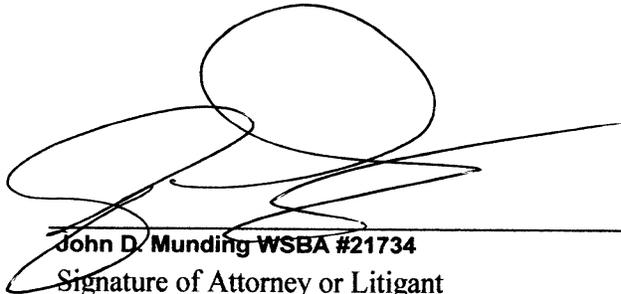
