ADDENDUM TO SUMMARY OF SCHEDULES

Debtor and its Affiliate Hamp Haven Farms hereby draw the Court's attention to the fact that the Summary of Schedules in each of these two related cases is misleading in that a substantial amount of the debt described in each Petition is owed by both Debtors. The joint debt is not readily allocable to one entity or the other, and Debtors believe it will create less confusion to list the full amount due in each Petition. The Summary of Schedules, however, is misleading because it totals all joint debt in each case, double-counting debt while counting assets only once. The amounts involved are substantial – 5 of the creditors on Schedule D*, with secured claims totaling \$5,318,160.50, are double-counted on each Petition.
